

Cancellation Instructions

- 1. Complete all information. Incomplete forms will be returned unprocessed.
- 2. Copy of the original customer's agreement or a copy of the agreement with "VOID" written on the contract must be attached for cancellation.
- 3. Include all supporting documentation for payoff, refinancing, voided sale, trade, repossession or other necessary supporting documentation to substantiate the cancellation request.
- 4. Send all copies to your Selling Dealer.
- 5. If there is a lienholder listed on the agreement, all refunds will be paid to the lienholder unless proof of payoff is provided with the cancellation request.
- 6. All cancellations are final and coverage cannot be reinstated for any reason.
- 7. If this request is for any reason other than a cancellation due to a repossession, voided sale, or buy-back, the customer MUST sign this request. For all requests for cancellation due to repossession, the cancellation request must be accompanied by proof of repossession by lender/lessor. If customer's signature is not obtainable on this cancellation request, a signed letter from the customer or lender must be provided.
- 8. A separate cancellation request must be submitted for each product being cancelled.
- 9. The requested cancellation date cannot be any earlier than the date this form is completed and signed by the customer. This request must be submitted to NWAN, Inc. at the address identified below within thirty (30) days of the requested cancellation date, or the cancellation will be recalculated based on the date the cancellation request is received by NWAN, Inc.
- 10. All Extended Service Agreements must be submitted with a current odometer statement, signed by the customer and a dealer and/or Bureau of Motor Vehicles.
